FHI 360 works with its partners around the world to create new jobs and business opportunities, prepare workers to take advantage of expanding opportunities and equip people in need to earn a better living.



At FHI 360, we work to expand economic activity, create new and sustainable employment and improve the livelihoods of people who have limited access to financial opportunities. Our programs build partnerships among government agencies, nonprofit organizations and private firms in order to give individuals and local businesses the tools they need to compete in a rapidly expanding economy.

### Food security and household economic strengthening

We work with vulnerable populations to help them protect their household assets and prepare for unexpected circumstances. Our projects link income-generating activities to the local market to ensure sustainability. We also work with local partners and the private sector to strengthen livelihoods and improve the ability of households to access adequate and appropriate food. This includes a range of social protection measures, such as encouraging household savings, managing money and accessing capital in more appropriate ways.
