The complex and highly localized nature of violent extremism (VE) makes it difficult to predict, control, and prevent unless those closest to it are equipped with the tools they need to identify and understand the drivers, and devise community-led responses to prevent its spread and strengthen resilience to its pull.

For the last eight years, FHI 360 has been working with civil society actors on the frontlines of efforts to better understand, prevent, and counter VE in their countries and communities. The starting point of our approach has always been to engage young people and their communities, including civil society organizations, local officials, and citizens, to identify and create their own constructive measures to mitigate local VE drivers and strengthen resilience to the pull of VE. In some places, these alternatives are dynamic efforts to use local culture to connect with youth on the margins, while in other places this means work with charismatic leaders to disseminate compelling messages of tolerance and peace. Whatever the form, we have seen this localized approach yield the greatest success because it overcomes the risk to self-impose a "one-size-fits-all" solution to VE that does not exist, and it promotes local leadership that can be sustained for the future.

CVE TOOLS AND METHODOLOGIES

FHI 360 has proven tools and methodologies that empower and engage young people and communities in CVE. These include:

- Community Youth Mapping. Used by FHI 360 on two USAID-funded CVE activities: the Peace through Development (PDEV) program in Niger and Chad, and the current Sharekna pilot activity in Tunisia. Community Youth Mapping is a community-based methodology that empowers youth and adults to collect, analyze, and disseminate information that informs the creation of locally-driven positive alternative narratives to VE. This process incorporates youth's aspirations, assets, and factors of resilience in order to engage them as partners in countering violent extremism rather than as mere subjects of outside interventions.
- SCALE+. Used on USAID programs across the globe, including in Kenya, Mali, Malawi, Nepal, and Tunisia, SCALE+ provides a systems-based methodology for involving a multi-sectoral group of community stakeholders to identify and resolve key community challenges, often conflict- or VE-related. USAID has called the approach "one of the most accessible and practical implementations of systems thinking [we have] seen."
- The Good Governance Barometer. Applied on USAID programs in Senegal,
 Mali, and Nepal, the Good Governance Barometer (GGB) enables
 communities to define, monitor, and measure what good governance means
 to them. As a tool for strengthening inclusive governance, the GGB assists in
 diminishing one of the leading structural drivers of VE poorly governed
 areas and perceptions of marginalization.

CONTINUOUS EFFORTS TO INNOVATE THE CVE SPACE

At FHI 360, we are also driven by a desire to continuously innovate, and we are currently piloting new initiatives that empower youth and communities to lead CVE efforts. These efforts include:

- Long-term mentoring of organizations on the frontlines of countering violence and VE in their communities;
- The integration of positive youth development into CVE activities, so that youth are engaged by communities and empowered to be catalysts of positive change;
- The use of developmental evaluation methods to adaptively manage and evaluate the evolution of community-led responses to VE; and
- Ongoing initiatives to share and disseminate local perspectives, knowledge, and research for CVE.
