

## Mpox Training Resources—User Guide

### Two available resources

- **Mpox Training for Clinical Providers** (e.g., doctors, clinicians, nurses, other medical personnel involved in providing mpox clinical services)
- **Mpox Training for Peer Outreach Workers** (peer navigators, other lay workers providing mpox services)

### How to use the training presentation for clinical providers

EpiC's technical team compiled the most current information on mpox in this presentation that contains 14 modules. The modules include background; epidemiology; modes of transmission; signs and symptoms; diagnosis; case definition; exposure; treatment; prevention; special considerations; infection prevention and control; communication and literacy; surveillance, monitoring, and evaluation; and EpiC's response. Each module includes learning objectives, slides for sharing technical information with participants, speaker notes and instructions for the facilitator, and a knowledge-check activity. The presentation can be adapted for face-to-face, online, or blended training events.

Facilitators using the presentation are expected to:

- Adapt the presentation to their audience, approach, and geographic location
- Share the training goals, objectives, expectations, and agenda with-participants in advance
- Update the slides related to the mpox outbreak to incorporate the most current data and reflect the epidemiology based on their context
- Build in opportunities for participants to interact with the content and each other (e.g., ask questions, challenge them to use the information presented, and instigate discussion on how they will apply what they are learning)
- Share copies of the technical information participants will reference (e.g., create job aids from the key slides, incorporate the actual forms and procedures that providers use at their workplace) and make them available during the training
- Develop a case study for participants to demonstrate what they have learned
- If clinical providers will be working in conjunction with peer outreach workers to carry out mpox services, include specific details of how roles and responsibilities will be shared

### PREREQUISITE SKILLS

**Facilitators** should be master clinical trainers with expertise in the subject matter and successful completion of the training-of-trainers orientation.

**Participants** should be licensed clinical providers who currently provide (or will provide) services to clients with mpox.

## How to use the training presentation for peer outreach workers

EpiC's technical team modified the presentation for clinicians to include information appropriate to the roles and responsibilities of peer outreach workers and other lay workers. Each module includes learning objectives, slides for sharing technical information with trainees, activities to conduct with the participants, speaker notes and instructions for the facilitator, and a knowledge-check activity. The presentation can be adapted for face-to-face, online, or blended training events.

Facilitators using the presentation are expected to:

- Adapt the presentation to their audience, approach, and geographic location
- Share the training goals, objectives, expectations, and agenda with participants in advance
- Update the slides related to the mpox outbreak to incorporate most current data and reflect the epidemiology based on their context
- Use/adapt the activities described and build in additional opportunities for participants to interact with the content and each other (e.g., ask questions, challenge them to use the information presented, and instigate discussion on how they will apply what they are learning)
- Share copies of the technical information that participants will reference (e.g., create job aids, incorporate the actual forms and procedures that peer outreach workers use) and make them available during the training
- Develop a case study for participants to demonstrate what they have learned
- Ensure the training includes specific details on how roles and responsibilities will be shared between peer outreach workers/lay workers and clinical providers

### PREREQUISITE SKILLS

**Facilitators** should be master trainers with expertise in the subject matter and successful completion of the training-of-trainers orientation.

**Participants** should be experienced peer outreach workers/lay workers who currently provide (or will provide) services to clients with mpox.
