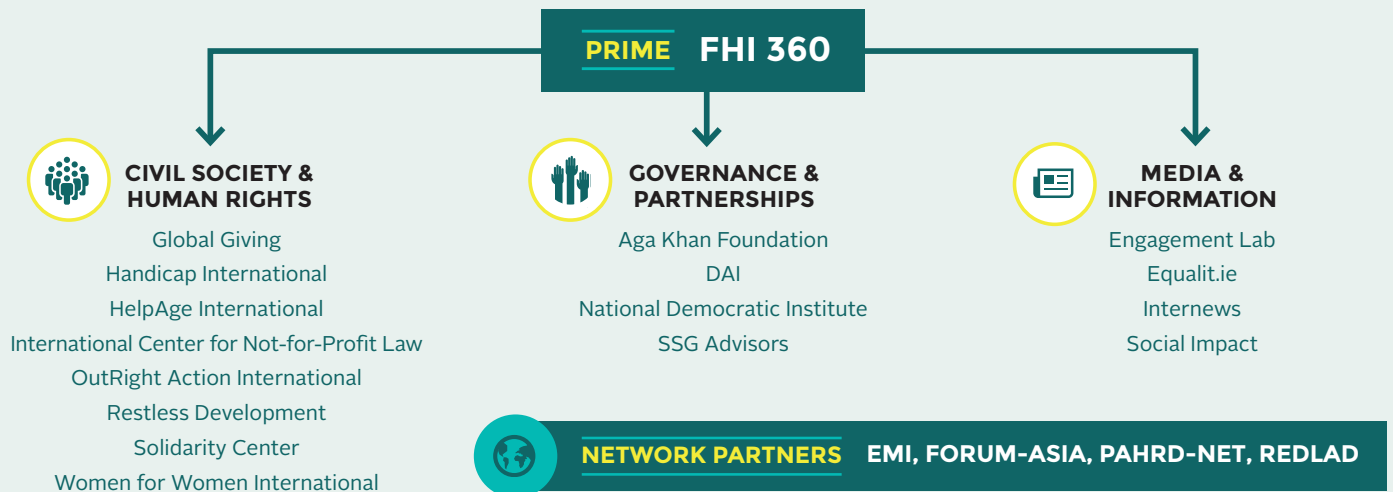


INTEGRATION
