# Protecting yourself from identity theft

Millions of Americans are affected by identity theft each year. Learning about the risks of identity theft can help you protect yourself against these crimes.

### Why do I care about identity theft?

#### How can you protect your identity?

On the next page are some things you can do to reduce your risk of identity theft. Most of these tips come from the FTC.

#### Protecting yourself online

- Use passwords that can't be easily guessed by people who have information about you.
- Shop on secure websites only (the web address for secure websites starts with https://).
- Do not put personal information on public computers (like in libraries and schools).
- Install or activate security software on your computer to protect yourself.

#### Protecting yourself in life

- Keep medical records, bills, paychecks, and other personal documents in a safe place.
- Shred documents that have your personal information.
- Keep your Social Security card and any other documents that show your Social Security number in a safe place. Don't carry your card or other documents that display your number.
- Don't share your Social Security number unless you have to, like when you get a job or open a bank or credit union account.
- Don't share your personal information in emails or on social media.
- Do not respond with personal information to someone who emails or calls you claiming to need it. Verify the source before sharing the information.
